ORDER

As per G.O read as 1st paper above, Administrative Sanction was accorded for the implementation of the Kerala Fibre Optic Network (KFON) project which aims to provide hassle free internet access to about 30,000 Government offices and educational institutions and also to provide high speed internet connectivity to the economically backward families all over the State. Subsequently revised Administrative Sanction was accorded for the project as per G.O read as 4th paper above,.

2) Government have constituted an Expert Technical Committee for the implementation of the project with Secretary (E&IT) as the convenor vide G.O read as 2nd paper above. As per G.O read as 3rd paper above, Kerala State IT Infrastructure Limited (KSITIL) was made the Nodal Agency for all infrastructure developments in IT sector, all constructions and connectivity activities. KSITIL was also assigned as SPV for the construction / project activities carried out through KIIFB funding.

3) As per letter read as 5th paper above, the Managing Director, KSITIL has informed that technical sanction for a project shall only be issued by the competent authority having delegation of powers granted by Government and in the absence of the such an authority, a Technical Committee has to be constituted for the purpose. As such the Managing Director, KSITIL has requested to constitute a Technical Sanction Committee for all KIIFB funded Engineering projects of KSITIL and also requested to constitute another Technical Sanction Committee for KIIFB funded Telecom projects of KSITIL including Kerala Fibre Optic Network (K-FON Project).

4) Government have examined the matter in detail and are pleased to constitute a Technical Sanction Committee for all KIIFB funded Engineering projects of KSITIL with the following composition:
